5. ESGCT Board: Confirmation and mandate for prolonging term of Executive Board until annual meeting 2022. The members ratified the prolonging of the mandates of the Executive board for one year until October 2022 with Hildegard Buning as President, Juan Bueren as Vice President, Alberto Auricchio as General Secretary and Axel Schambach as Treasurer.

The members also voted for prolonging the mandate of the rest of the board for 1 year, voting in Vincenco Cerullo, Claire Booth, Alessandro Aiuti, Gloria Gonzalez Aseguinolaza, Zoltan Ivics, Giuliana Ferrari.

6. ESGCT Board Report of the Treasurer: 2020 accounts: AS explained that no meeting in 2020 had an impact on the financial position of the society. No event could be ran but costs had been incurred due to prior planning and contracts then being cancelled. AS then presented the financial status of the accounts and explained due to the COVID year the deficient could be understood but the society was in good shape due to previous careful planning. AS went on to explain that next year he would be able to show the financial position of the society in good light due to the 2021 virtual event and that the cashflow is needed to enable ESGCT to organise successful events in the future.
