- 4. Report of the president: HB gave an overview of the society and advised ESGCT has been in the field now for 30 years. HB provided an overview on membership figures (1498 current members), the society journal with HGT and the special addition for the annual congress with guest editor Andy Baker (congress president), the national



societies and beyond Europe the relationships with ASGCT, JSGCT & AGCTS where ESGCT actively co-organise sessions and webinars.

HB explained about the various awards ESGCT has in place:

Outstanding Achievement Award – for 2022 awarded to Christof von Kalle and Manfred Schmidt (posthumously)

Founders Award – new for 2022, HB explained the concept and that it was presented to Jude Samilski (AV Vectors)

Young Investigator Award – for 2022 awarded to Eliana Ruggiero (Milan) & Raul Torrres (CIEMAT)

LT followed with an overview of the student activities undertaken in Edinburgh & the impact of these events for the student and that mentoring was a big focus for the future. She then went on to explain about the social media coverage with an increased following being seen especially Instagram and LinkedIn. The student board members are looking to organise future talks with senior scientists and young science divulgators.

6. Year 2022 - Overview

HB provided a summary of Edinburgh which had been postponed since 2020 and was organised in collaboration with BSGCT. It was the 1st in-person congress since Barcelona and was sold out which was unique to ESGCT. There were 2023 inperson registrations and 224 virtual. There was a large number of industry registrations with academics and students also being well represented. Over 800 abstracts were submitted and a big thank you to all the sponsors of the congress. Spring School took place in Athens in April and was the first ESGCT in-person meeting since 2019. Good networking opportunity for students

ESGCT Academy – new activity launched for 2022 with 15 students focussing on a specific topic which this time was hosted in San Sebastian on AV Vectors.

7. Report of Treasurer 2021

HB thanked AS for his contributions as treasurer.

AS explained the financial report in detail and that it left an operating profit of €580K

A question was asked on which country ESGCT established in – AS answered

Germany and that approval has to be sought every 3 years from the Germany tax authorities to maintain their status.

AS also thanked Manuel Grez for auditing the accounts.

Discharge of the Management Board and formal approval of the 2021 accounts AS requested the discharge of the executive Board and that everyone except the board were able to vote, Ayal Hendel asked for the board to be discharged. The management board is discharged and the 2021 have been formally approved.
